Georgia Power's Wiring Assistance Program begins January 1, 2012, and ends December 14, 2012. Participation will be limited to a total of 40 commercial and industrial food service customers of Georgia Power. Only the first 40 eligible customer accounts whose installations are completed, and who submit a valid and complete application by December 14, 2012, will receive reimbursement payments. Payment amount is actual amount of electrician's wiring cost, or \$20 per connected kW (lesser of two amounts) up to a maximum of \$2,000 per customer account.

WIRING ASSISTANCE PROGRAM QUALIFICATIONS:

- Must be an existing Georgia Power commercial customer
- Must be installing electric cooking equipment (replacement, conversion, or add-on, consisting of fryers, ovens, kettles, ranges, skillets, steamers, char-broilers, and specialty cooking equipment)
- Must be on any business or institutional rate except Real Time Pricing (RTP)
- Each qualifying commercial cooking equipment item must have a nameplate greater than 5kW
- Rebate to the customer will be the lesser of electrician's actual detailed and paid invoice or \$20 per kW, with a per customer account maximum of \$2,000
- Customer will submit a Wiring Assistance Plan Application (request for payment) and the electrician's actual invoice, or the electrician's quote for service & proof of purchase
- Customer is responsible for meeting compliance requirements under terms of offer
- Program begins January 1, 2012 and ends December 14, 2012
- No later than December 14, 2012 applicant must submit valid, completed application, and all qualifying equipment must be installed by an electrician and verified in person by a Georgia Power representative

TERMS AND CONDITIONS

1. **Participation.** The Wiring Assistance Program (the "Program") sponsored by Georgia Power Company ("Georgia Power") is a program, expressly limited as set forth in this application. Participation in the program will be limited to, and reimbursement payments will be provided only to, the first forty (40) commercial or industrial food service customer accounts of Georgia Power meeting all necessary criteria who complete qualified electric installations and submit valid, completed reimbursement applications (including all required enclosures) by December 14, 2012. Reimbursement payments will be made only to such customers who are billed according to a business or institution rate other than Real Time Pricing. Reimbursement payments will be made only to such customers who install electric commercial cooking equipment (replacement, conversion or add-on) consisting of fryers, ovens, kettles, ranges, skillets, steamers, char-broilers or specialty cooking equipment. Such equipment must have a nameplate rating greater than 5kW to qualify for reimbursement. In order to qualify for reimbursement, installation of qualified equipment must occur between January 1, 2012 and December 14, 2012, and a representative of Georgia Power must verify in person the installation and qualifications prior to December 14, 2012.
2. **Reimbursement.** Total reimbursement payment made to each qualifying participant, regardless of the number of pieces of equipment installed, will be equal to the lesser of the following: (a) the amount actually paid by the participant to the electrician for electrical wiring in connection with the Program (as set forth in a detailed invoice); (b) Twenty Dollars (\$20.00) per kW of the installed electric cooking equipment rating; or (c) Two Thousand Dollars (\$2,000.00).
3. **Limitation of Liability; No Warranties.** BY SIGNING THIS WIRING ASSISTANCE PROGRAM APPLICATION, APPLICANT ACKNOWLEDGES AND AGREES THAT GEORGIA POWER'S LIABILITY AND RESPONSIBILITY IN CONNECTION WITH THE PROGRAM SHALL BE STRICTLY LIMITED TO THE MAKING OF CERTAIN REIMBURSEMENT PAYMENTS TO ELIGIBLE APPLICANTS, AS DESCRIBED IN THIS APPLICATION APPLICANT FURTHER ACKNOWLEDGES AND AGREES THAT GEORGIA POWER IS NOT MAKING, WILL NOT BE PROVIDING AND SPECIFICALLY DISCLAIMS ANY REPRESENTATIONS, WARRANTIES, COVENANTS OR GUARANTIES WHATSOEVER, EXPRESS OR IMPLIED, IN CONNECTION WITH THE WIRING ASSISTANCE PROGRAM, INCLUDING, WITHOUT LIMITATION, THOSE REGARDING MERCHANTABILITY OR FITNESS, AND GEORGIA POWER SHALL IN NO WAY BE LIABLE OR RESPONSIBLE FOR ANY EQUIPMENT INSTALLED OR ANY ACT OR OMISSION OF ANY OTHER ENTITY OR INDIVIDUAL, INCLUDING, WITHOUT LIMITATION, ANY ELECTRICIAN OR OTHER SERVICE PROVIDER.
