**AVAILABILITY:**

Throughout the Company's service area from existing lines of adequate capacity.

**APPLICABILITY:**

Applicable upon request as a modification of the rate schedules for Power and Light, School Service and Full Use Service to Governmental Institutions when off-peak usage exists.

**DEFINITIONS:**

- A. OFF-PEAK usage is defined as power requirements occurring at all hours during the billing months October through May, all weekends, certain holidays, and various sixteen hour periods starting between 6:00 p.m. and 10:00 p.m. daily during the billing months June through September. The holidays to be observed are National Memorial Day, Independence Day, and Labor Day. The day on which the holiday is observed shall count as an off-peak day.
- B. ON-PEAK usage is defined as all power requirements not included above.

**DETERMINATION OF BILLING DEMAND:**

The Billing Demand shall be based on the greater of the applicable percent of the highest Off-Peak or On-Peak 30 minutes kW measurement during the current and preceding eleven (11) months.

In no case shall the Billing Demand be less than the greatest of (1) the contract minimum, (2) fifty percent (50%) of the total contract capacity, or (3) the demand minimums as stated in each of the "Power and Light", "School", and "Governmental" rate schedules to which this rider is applicable.

When this rider is used to modify the School Service Rate Schedule, the Billing Demand for the billing months of June through September shall be the lesser of the current actual demand or the demand determined by the appropriate applicable percent.

**METERING:**

The customer may be responsible to the Company for any additional cost of installing and removing any equipment required to meter or deliver this service.

**TERM OF CONTRACT:**

Not less than one year on the selected schedule.

**GENERAL TERMS & CONDITIONS:**

Service hereunder subject to Rules and Regulations for Electric Service on file with the Georgia Public Service Commission.
