**AVAILABILITY:**

Throughout the Company's service area from existing lines of adequate capacity.

**APPLICABILITY:**

To all electric service required for the operation of electric transportation, delivered at multiple points as needed, and metered at or compensated to a standard voltage.

**TYPE OF SERVICE:**

Three phase, 60 hertz, at 19,800 volts or higher.

**MONTHLY RATE:**

All energy consumed will be priced according to the schedule below.
