AVAILABILITY:

Throughout the Company's service area from existing lines of adequate capacity.

APPLICABILITY:

Applicable to electric service for the operation of traffic control devices owned and operated by a municipality or government agency and located on a public street or highway.

A Traffic Device is defined as traffic control related equipment not defined as School Flasher or Traffic Flasher.

TERM OF CONTRACT:

One (1) year.
