## An example of how our Limited-Time Savings Offer works

## Apply now for our Limited-Time Savings Offer.

- ▶ All applications must be submitted during the promotional period through the Commercial Rebate Application Center and meet eligibility guidelines.
- ▶ All applications submitted during the promotional period will be paid once the project installation is completed and all documents are received.
- ▶ The date close-out documents are received for a project determines the additional rebate amount offered to the customer.
  - December 31, 2023, for 100% additional rebates
  - March 31, 2024 for 15% additional rebates
- ▶ Limited-Time Savings Offer rebate funds are limited and available on a first-come, first-served basis.
- ▶ Limited-Time Savings Offer will not count toward the annual cap per project type, per building.
- ▶ All rebates capped at 50% of the total equipment cost will also be eligible for the additional Tier 1 (100% rebate if project completed by December 31, 2023) or Tier 2 (15% rebate if project completed by March 31, 2024) rebate on top of the 50% cap.
