In addition, GPC will require a nonrefundable administrative fee of \$250.00 for lease preparation and review, along with a Rental Fee to be determined by the Land Sales Department. Preparation of the lease will take an additional 1-2 months.

Any such obligations shall arise only in the event of execution by both GPC and Applicant of a definitive, written agreement for a lease of the subject property, incorporating such terms, conditions, provisions, and matters as GPC and Applicant shall negotiate, and unless and until such a binding agreement is so executed, GPC may take any action with respect to the subject property as GPC, in its sole discretion, shall elect (including without limitation the sale, exchange or lease of GPC's interest, if any, in the subject property to a third party).
