

A request for Georgia Power to quitclaim easement(s) and/or fee property can be submitted by completing the following application. The completed application should be mailed to the below address, and must be accompanied by payment of a **nonrefundable application fee of \$250.00**, a map or plat illustrating the subject property, copies of any relevant documents that pertain to your request, and a letter detailing the reason for your request. If you are requesting a quitclaim of easement(s), you must also include a copy of the easement(s) to be released, as well as a copy of the deed evidencing your ownership of the underlying property.

GPC will review the application and submitted documentation to determine whether it is able to execute a Quitclaim Deed relinquishing the easement rights and/or ownership rights identified in your application. **The review process could take approximately 3 months.** If GPC agrees to execute and deliver a Quitclaim Deed, GPC will require a **nonrefundable administrative fee of \$1,500.00** for the first easement and/or fee property to be quitclaimed, and **\$500.00** for each additional easement and/or fee property to be quitclaimed, if any. Preparation of the Quitclaim Deed(s) will take an **additional 1-2 months.** You may also be required to pay an additional charge based upon GPC's determination of the fair market value of the subject property.
