



# WORKFORCE FOR GEORGIA GRANT PROGRAM REQUEST FOR PROPOSALS GUIDELINES 2024

#### About the Workforce for Georgia Grant

The Georgia Foundation for Public Education, in partnership with the Georgia Power Foundation, Inc., is pleased to announce the request for proposals (RFP) for the third round of the Workforce for Georgia Grant Program. The grant program provides up to \$50,000 to schools and school districts that offer Career, Technical, and Agricultural Education (CTAE) through traditional high school programs or through College and Career Academies (CCA), with support to invest in implementing or scaling programs to better serve students and instructors in the continuation of programs and/or program alignment of educational and training pathways to meet workforce needs of local and regional communities' industries and businesses. Up to \$1,000,000 will be awarded in grant support from Georgia Power Foundation, Inc.

#### **Submission Instructions**

To participate in the Workforce for Georgia Grant, please follow the steps below:

- 1. Carefully review this document, including the eligibility requirements and application components.

We strongly recommend that you thoroughly review the application questions (pages 3-4) prior to completing the application to ensure you have a solid understanding of the application expectations.





#### **Eligibility Requirements**

School districts may submit more than one grant application. Individual schools may only submit one grant application. More than one submission per individual school will disqualify all applications from the school. Collaboration amongst schools within the district is highly encouraged.

You are eligible to apply for a Workforce for Georgia Grant if:

- You are a district-level staff at a school district with one or more high schools/CCAs with CTAE programs in the state of Georgia; or
- You are a school administrator, principal, or instructional coach at a charter school or traditional public school in the state of Georgia.

### **How Can I Use Workforce for Georgia Grant Funds?**

The Workforce for Georgia Grant will provide College & Career Academies and Georgia school districts with CTAE programs with grant support to meet workforce needs of their communities' local industries and businesses.

Applicants may request up to \$50,000 over 12-18 months to start a new pathway program **OR** to implement programs that expand or support current CTAE programs and/or for program alignment of career pathways.

Some examples of how funding may be used includes, but is not limited to:

- Hardware, software and/or other startup cost associated with the expansion or establishment
  of a new pathway program to facilitate work-ready curriculum to prepare students to enter
  the job market after graduation.
- Alignment of career pathway offerings with local business and workforce needs.
- Professional training and/or certification for teachers and instructors to provide educational opportunities related to local industry needs.

Allowable expenses may include materials, equipment, staff time, etc. but must be tied directly to the outcomes you are trying to achieve. If requesting funds to start a new pathway, please include data to support the need and sustainability of the program.

## How long will the Workforce for Georgia Grant funds last?

Workforce for Georgia Grant recipients have between 12-18 months from the award date to use their funds. If needed, grant extensions are allowable and must be requested in writing.

## If I receive a Workforce for Georgia Grant, what are the expectations?

The expectations for Workforce for Georgia Grantees are:

- The Workforce for Georgia Grant will be awarded up front.
- Each grantee will be required to sign a grant agreement before funds are released.
- Workforce for Georgia Grantees are responsible for tracking the outcomes of the project or program. Grantees will submit two evaluation reports indicating impacts of the





program to date: One at mid-year and one upon completion of the program. The evaluation reports are the grantee's opportunity to share the project's progress, outcomes, lessons learned, and best practices.

- All grantees must distribute a retrospective survey to students participating in the funded program. The GFPE will provide the survey to grantees towards the end of the grant period and the grant manager will be responsible for ensuring the participants have ample time to complete the survey.
- Representatives from Georgia Power Foundation and the Georgia Foundation for Public Education will request an in-person or virtual site visit in spring 2025 to observe the program/project in action.
- Any media or social media posting should include Georgia Power Foundation's and the Georgia Foundation for Public Education's logo, social media handles, and be shared.

Project Description (5 Points)	In 350 words or less, provide a brief description of the project you would like to implement or expand (If you are a CTAE program, please utilize your school district's Perkins V Comprehensive Local Needs Assessment (CLNA)). In your summary, please include:  a) An overview of the need; b) How you will use the grant funds to address the need; c) Overview of who will be served by the program; d) A description of any partners/partner organizations and how they will support the project, if applicable; and e) Indicate if this is a continuance of a Workforce Development grant awarded in 2020 or 2022 from Georgia Power Foundation.
Community Need: New Pathway Grants Only (5 Points)	In 300 words or less, please explain the local/regional labor market need for the new pathway. In your answer, include:  a) the data you used to determine the need for the new pathway;  b) how you can ensure that, if awarded, you will have the capacity to implement the program effectively; and  c) a sustainability plan after the grant period (if awarded). Please make sure you reference the Locally Developed Pathway Course Process before applying.
Community Need: Expansion Grants Only (5 Points)	In 300 words or less, please explain the need to expand the program. In your answer, include:  a) the data you used to determine the need for expanding the program; b) how the program was funded in the past; and c) a sustainability plan after the grant period (if awarded).
Program Inputs (5 Points)	In 250 words or less, provide a description of the program activities or inputs. In your answer, please include:  a) How can you ensure that, if awarded, you can implement the project immediately?  Include the proposed project start-date, key intermediate milestones, and
