**AVAILABILITY:**

Throughout Georgia Power's service area from existing lines of adequate capacity. Service under this tariff is limited by the availability of Renewable Energy Credits (RECs) for purchase by the Company.

**APPLICABILITY:**

Applicable, upon request, to customers with an average monthly usage greater than 100,000 kWh for the previous twelve months.

Customers must purchase a monthly minimum of 100,000 kWh of RECs and contract with Georgia Power for a fixed term and a fixed quantity, up to 100% of the customer's annual energy usage. Customers that operate as a single brand under (1) common ownership or (2) common control via a written franchise agreement with a single controlling entity may aggregate their annual energy usage for purposes of participating under this program.

**DESCRIPTION:**

Flex REC enables Georgia Power to purchase and retire RECs generated from renewable energy resources on behalf of participating customers. RECs will be retired according to each customer's subscription level. RECs for this program may be sourced from solar, wind and other renewable sources deemed acceptable by the Company.

**MONTHLY RATE:**

Tiers	REC Charge
Tier 1	First 100,000 kWh at 1.2500¢/kWh
Tier 2	Next 150,000 kWh at 1.0000¢/kWh
Tier 3	Next 350,000 kWh at 0.7500¢/kWh
Tier 4	Next 400,000 kWh at 0.6250¢/kWh
Tier 5	All kWh >1,000,000 kWh/month at Contracted Market Price + 5%

The monthly REC charge will be in addition to the participating customer's normal cost of electricity pursuant to the customer's existing retail electric service tariff.

**MUNICIPAL FRANCHISE FEE:**

The bill calculated under this tariff will be increased under the provisions of the Company's effective Municipal Franchise Fee Schedule, including any applicable adjustments.

### TERM OF CONTRACT:

Service under this tariff shall be for a period of not less than six (6) months. The Company reserves the right to terminate any or all contracts and/or this tariff at the Company's discretion.

If state or federal laws are instituted requiring Georgia Power to provide renewable resources, RECs or otherwise meet a renewable compliance standard, the Company reserves the right to cancel all contracts and sales through this tariff, without penalty.

### FLEX REC ECONOMIC DEVELOPMENT OPTION

The Economic Development option is available to customers who purchase a minimum of 2,000,000 kWh monthly and who contract with the Company for a fixed quantity and term.

The Flex REC Economic Development option will be a charge in addition to the customer's regular electric service. This option is customer specific and will be negotiated by Georgia Power and the customer on a case-by-case basis.

The Customer and Company will agree to and contract for a specified term (one to three years) for which the Company will procure RECs for the customer.

After the conclusion of the contract period, standard Flex REC monthly tiered pricing shall apply as filed under the Flex REC Tariff.

### SPECIAL EVENT PURCHASE OPTION:

Georgia Power may provide a Special Event Purchase Option for special events through one-time REC purchases. A special event refers to a non-permanent assembly (e.g., a conference, concert, sporting event, etc.) and this option cannot be used to procure RECs for permanent facilities. The Company will contract with each interested customer individually on price, quantity, source, and term.

### ONE TIME PURCHASE OPTION:

Georgia Power may provide a One Time Purchase Option for customers interested in meeting a specific requirement. These RECs can be used to meet the need for permanent facilities. The Company will contract with each interested customer individually on price, quantity, source, and term.

### GENERAL TERMS AND CONDITIONS:

The bill calculated under this tariff is subject to change in such an amount as may be approved and/or amended by the Georgia Public Service Commission.

Service hereunder is subject to the Rules and Regulations for Electric Service on file with the Georgia Public Service Commission.
