Qualifications

To qualify as a minority-owned or female-owned business enterprise, your company must be at least 51% owned and operated by a minority or female, respectively". A minority or female owner must be actively engaged in, and control daily business operations". A minority owner must be a U.S. Citizen from one of the following ethnic groups: African-American, Asian-Indian American, Asian-Pacific American, Hispanic American, or Native American (as defined by the Small Business Administration).



Minority-owned or female-owned businesses also must meet our expectations for all suppliers: high-quality, competitively priced goods, and timely, responsive service.

Guidelines

Southern Company affiliates are committed to the highest standards of ethical conduct and legal compliance. Our contracts include provisions which specifically require suppliers to conduct their activities in a highly ethical manner and in compliance with applicable laws and regulations.
