This value is calculated as a dissolved concentration for an appropriate comparison to the numeric water quality criteria, which are also in the discovered from Consistent with Georgia EPD, non-detectable effluent concentrations are not translated into Calculated Receiving Water Concentrations.

 5 Numeric Valer Quality Circleria is the maximum concentration of a parameter (calculated at a default harteness of 50 mg/L as calcium carbonately established for the receiving waterbody that will be protective of the designated use per Georgia EPD's rules and regulations. Calculated Receiving Water Concentrations less than these criteria are protective of the waterbody.
