Consistent with Georgia EPD, non-detectable effluent concentrations are not translated into Calculated Receiving Water 6 Numeric Water Quality Criteria is the maximum concentration of a parameter (calculated at a default hardness of 50 mg/L as calcium carbonate) established for the receiving waterbody that will be protective of the
- designated use per Georgia EPD's rules and regulations. Calculated Receiving Water Concentrations less than these criteria are protective of the waterbody.
