## 1. INTRODUCTION

The Grumman Road Ash Landfill is located on Gulfstream Road in the city of Port Wentworth, Chatham County, Georgia. The site is approximately five miles north of Savannah, Georgia, east of the Savannah Municipal Airport, and approximately two and one half miles west of Georgia Power Company's former Plant Kraft.

The Grumman Road Ash Landfill consists of four parcels; Parcels A, B1, B2, and B3. Each parcel contains a landfill cell. Parcel A operated under the Solid Waste Handling Permit number 025-034D(LI) and Parcels B1, B2, and B3 operated under the Solid Waste Handling Permit number 025-061D(LI). Parcel A ceased receiving ash prior to the 1986 permit issuance for Parcels B1, B2 and B3. Parcels A and B1 were closed together in 2004. The certification of the final closure can be found in the report named Cells A & B1 Certification for Closure by Earth Science and Environmental Engineering Technical Services Southern Company Generation dated January 2007. Parcels B2 & B3 were also previously closed and certified in the report named Certification Report Grumman Road Ash Landfill Parcels B2 & B3 Closure Final Cover Construction by Brantley Engineering, LLC, Dated November 30, 2017.

The Grumman Road Ash Landfill is an Inactive Coal Combustion Residual (CCR) Landfill under the CCR Rule 391-3-4.10(2) and was closed in place. The facility stopped receiving CCR prior to October 19, 2015 and provided the formal notice of closure to EPD in a letter dated November 4, 2015.

CCR and roofing material were encountered outside the permitted waste boundary on Parcels B2 & B3 and was removed and hauled off to an approved Subtitle D Landfill with an approved CCR Management Plan. The removal areas are referenced as 1-4, Phase 1, and are described in the Certification of CCR Removal Report Grumman Road Ash Landfill Areas 1-7 (Phase 1&2) by Brantley Engineering, LLC, Dated November 8, 2019.

CCR material was encountered in subsurface investigations outside the closed portion of Parcel A, as well as within the buffer zone of Parcels A and B1. The CCR within the buffer zone was excavated and relocated to parcel A', the area adjacent to the closed portion of parcel A. The removal areas are referenced as 5-7, Phase 2, and are described in the Certification of CCR Removal Report Grumman Road Ash Landfill Areas 1-7 (Phase 1&2) by Brantley Engineering, LLC, Dated November 8, 2019. The conjunction with the CCR removal activities final capping activities were detailed in the Closure Construction Certification Report Grumman Road Ash Landfill Parcel A' (Prime) Closure Final Cover Construction by Brantley Engineering, LLC, Dated November 8, 2019.

Georgia Power plans to remove CCR currently supporting power distribution structures just south of Parcel B2 as shown on the Permit Drawing 3 of 10. Once removed, the CCR will be hauled off site and disposed of in an appropriately permitted landfill. Upon completion of CCR removal and restoration of the area, a CCR Removal Certification Report prepared in accordance with the updated CQA Plan will be provided to EPD for review and approval. The previously submitted Construction Certification Report

Grumman Road Ash Landfill Parcels B2 & B3 Closure Final Cover Construction, dated November 30, 2017, Closure Construction Certification Report Grumman Road Ash Landfill Parcel A' (Prime) Closure Final Cover Construction, dated November 8, 2019 and Certification of CCR Removal Report Grumman Road Ash Landfill Areas 1-7 (Phase 1&2) dated November 8, 2019 will be revised and resubmitted to EPD for review and approval.

Georgia Power is submitting the information attached in support of an application for a solid waste handling permit as required under Rules 391-3-4-.10(9)(a), 391-3-4-.10(9)(b), and 391-3-4-.10(9)(c)4 which requires the application to address the subparagraphs of (9)(c)3.(i) – (iv) of the Rule for existing CCR landfills as follows:

## General CCR Unit Permit Application Requirements

- 391-3-4-.10(9)(b)1. A completed form designated by EPD.

  The completed form is included in Section 2 of Part A of the permit application

Financial Assurance is addressed in the closure narrative (included in Part A of this permit application) and will be provided once EPD concurs with the closure estimates provided in the permit application.
- 391-3-4-.10(9)(b)5. A qualified professional engineer's certification that all application requirements have been met.
  - The professional engineer's certification is included in Section 3 of Part A of the permit application.

## **Inactive CCR Landfill Permit Application Requirements:**

- 391-3-4-.10(9)(c)3.(i) Location Restriction Demonstration (40 CFR 257.64 Unstable Areas).
  - The location restriction certification is included in Section 1 of Part B of the permit application.
- 391-3-4-.10(9)(c)3.(iii) Groundwater Monitoring Plan (40 CFR 257.90, 91, 93 98).
  - A Groundwater Monitoring Plan has been prepared for the Grumman Road Ash Landfill in accordance with 40 CFR 257.90, 40 CFR 257.91, and 40 CFR 257.93 through .94 and is included in this application.

• 391-3-4-.10(9)(c)3.(iv) – Closure and Post Closure Care requirements (40 CFR 257.101, 102, 103, 104).

The Closure and Post Closure Care Plans provide narrative descriptions of how the CCR unit has been closed in accordance with 40 CFR 257.102(b)(1) and 40 CFR 257.104(d)(1).


