1. INTRODUCTION

Georgia Power Company (Georgia Power) owns and operates Plant McIntosh located in southeast Effingham County, Georgia. The plant is located approximately 4 miles northeast of the City of Rincon, Georgia and 20 miles north-northwest of the City of Savannah, Georgia. The plant property is on the west bank of the Savannah River at Big Kiffer Point, south from mile 41.4 to mile 43.1. Plant McIntosh comprises 10 generating units: eight – 80-megawatt (MW) combustion turbine units, and two – 660-MW combined cycle units.

In accordance with the Georgia Department of Natural Resources, Environmental Protection Division (Georgia EPD) Rules for Solid Waste Management, Rule 391-3-4-.10 – *Coal Combustion Residuals (CCR)*, Plant McIntosh Coal Combustion Residual (CCR) Existing Landfill No. 4 (Landfill No. 4) is classified as an Existing CCR Landfill. Landfill No. 4 is located on the western portion of the plant property, approximately 800 feet south of Lockner Creek. The landfill is comprised of four cells: Cell 1 is closed; Cell 2A is constructed and operational; Cells 2B, 3, and 4 were previously permitted but have not been constructed.

The Georgia EPD originally issued Solid Waste Handling Permit No. 051-010D(LI) on April 8, 2005, permitting the construction and operation of Landfill No. 4 in accordance with the Design and Operational Plan approved on March 23, 2005. Landfill No. 4 was originally permitted to be developed as 4 cells with a total volume of 4,845,839 cubic yards. Georgia Power modified the design and permitted airspace in a permit modification, dated March 10, 2015. The modifications allowed for the construction of a large detention pond, a leachate and wheel wash pond, and a wheel wash make up reservoir. In order to construct the ponds and reservoirs, Georgia Power decreased the size and volume of Cell 1 from a 9-acre and 1,085,725 cubic yard cell to a 3.8-acre and 356,108 cubic yard cell. The revised design capacity of Landfill No. 4 after the modifications is 3,763,221 cubic yards.

The total constructed capacity of Landfill No. 4 (Cell 1 and Cell 2A) is 707,878 cubic yards. In accordance with Rule 391-3-4-.10 this is the "Existing CCR Landfill". If in the future Georgia Power were to construct Cell 2B, 3, or 4, in accordance with Rule 391-3-4-.10 these cells would be considered a "Lateral Expansion of an Existing CCR Landfill". Georgia Power would submit a modification to the permit for a Lateral Expansion and be obligated to comply with the additional applicable requirements of the Rule.

Rule 391-3-4-.10(9)(c)3(v) requires a website address for information required to be posted by 40 CFR 257.105, 40 CFR 257.106, and 40 CFR 257.107. The information required to be posted and applicable to the Plant McIntosh Landfill No. 4 is found at:

Rule 391-3-4-.10(9)(b)4 requires a financial assurance mechanism meeting the requirements of Rule 391-3-4-.13. In compliance with applicable securities laws and regulations, GPC will provide cost estimates for closure to GA EPD under separate cover. The closure costs will include all items necessary for a third-party to complete the project in accordance with the Closure Plan as set forth herein. The closure cost estimate will be based on the largest area subject to final cover under the closure design and will be generated in current dollars. The cost estimate will be adjusted annually for inflation. GPC will provide a demonstration of financial assurance upon approval of the closure and post-closure care cost estimates by GA EPD.

Georgia Power is submitting the attached information in support of an application for a solid waste handling permit as required under Rules 391-3-4-.10(9)(a), 391-3-4-.10(9)(b), and 391-3-4-.10(9)(c)3 for

an existing CCR landfill. Each section includes a narrative portion describing the basis of design of the project, applicable regulatory requirements, and each of the engineering analyses performed to support the design and permitting of the facility.


