Re: Request for Closure Extension

Georgia Power Company - Plant McIntosh Ash Pond 1 (AP-1)

Effingham County

CCR Solid Waste Permit 051-011D(CCR)

Dear Mr. Cook:

On April 17, 2019, Georgia Power Company (Georgia Power) provided the Notification of Intent to Initiate Closure (NOI) for McIntosh AP-1 to the Georgia Environmental Protection Division (EPD). This NOI was placed on Georgia Power's public website in accordance with Solid Waste Management Rule 391-3-4-.10(8). CCR removal was completed and final acknowledgement of CCR removal was received on October 5, 2021; however, additional time to demonstrate decontamination in accordance with the facility's Solid Waste Permit and the Georgia Solid Waste Management Rules is necessary.

Solid Waste Management Rule 391-3-4-.10(7) requires closure of CCR units to be conducted in accordance with 40 CFR 257.102. Specifically, regarding closure timeframes, 40 CFR 257.102(f)(1)(ii) includes the requirement that existing and new CCR surface impoundments and any lateral expansion of a CCR surface impoundment must complete closure within five years of commencing closure activities. As anticipated in 40 CFR 257.102(f)(2)(i), extension of closure timeframes may be needed and can be extended upon demonstration that completion of all activities was not feasible within the designated timeframes.

A closure by removal strategy was selected for McIntosh AP-1in accordance with the requirements in 40 CFR 257.102(c). Closure construction activities were completed by removing all visible CCR from within the boundaries of the CCR unit. Certification of removal reports, demonstrating completion of removal activities, were submitted to EPD for Cells A – D. Based on a review of the reports and inspections of the site, EPD acknowledged the removal of CCR from Cells A - D in letters dated May 13, 2021 (Cell A), June 24, 2021 (Cell B), October 5, 2021 (Cell C), and October 5, 2021 (Cell D). However, in accordance with 40 CFR 257.102(c), closure by removal of a CCR Unit is completed by removing and decontaminating all areas affected by releases from the Unit. In accordance with 40 CFR 257.102(c), decontamination is complete when groundwater monitoring concentrations do not exceed the groundwater protection standard established pursuant to 40 CFR 257.95(h) for constituents listed in Appendix IV. Currently, two Appendix IV parameters, in two monitoring wells, are present in groundwater at statistically significant levels (SSLs) above the Groundwater Protection Standard. Per 40 CFR 257.95 (g)(3(ii), an alternate source demonstration (ASD) was prepared and submitted to EPD to address the SSLs.

Additional time to demonstrate decontamination and complete closure per 40 CFR 257.102(c) is required in order to coordinate with and obtain the necessary approvals from EPD for the ASD. Therefore, in accordance with 40 CFR 257.102(f)(2)(i)(D), and 40 CFR 257.102(f)(2)(ii)(A), an extension of two years is requested to obtain necessary approvals to demonstrate decontamination of the unit. This request

extends the timeframe for closure of the unit to April 17, 2026, and will be placed in the facility operating record.
