**Re: Request for Closure Extension  
Georgia Power Company – Plant Bowen Ash Pond 1 (AP-1)  
Bartow County  
Permit Number: 008-021D(CCR)**

Dear Mr. Cook:

Georgia Power placed the Notification of Intent to Initiate Closure (NOI) for Plant Bowen AP-1 in the facility's operating record on December 31, 2020. The NOI was subsequently placed on Georgia Power's public website, and a notification was provided to the Georgia Environmental Protection Division (EPD) in accordance with Solid Waste Management Rule 391-3-4-.10(8). Closure activities for the CCR unit are ongoing, and additional time to complete all activities in accordance with the facility's Closure Plan and the Georgia Solid Waste Management Rules is necessary.

Solid Waste Management Rule 391-3-4-.10(7) requires closure of CCR units to be conducted in accordance with 40 CFR 257.102. Specifically, regarding closure timeframes, 40 CFR 257.102 includes the requirement that existing and new CCR surface impoundments and any lateral expansion of a CCR surface impoundment must complete closure within five years of commencing closure activities. As anticipated in 40 CFR 257.102, extension of closure timeframes may be needed and can be extended upon demonstration that completion of all activities was not feasible within the designated timeframes.

The Plant Bowen AP-1 is a greater than 40-acre CCR facility that is being consolidated and closed in place in accordance with requirements in 40 CFR 257.102(d). Closure construction activities are ongoing.

Closure construction activities that have been completed include the following:

- CCR removal from approximately 44 acres;
- Foundation improvements to the consolidated area;
- Construction of and CCR placement within Cell 1A & 1B;

Additional time is needed to complete the remaining construction activities for closure as listed below:

- Construction of remaining cells and CCR placement;
- Installation of the final cover system over the filled consolidated lined area;
- Grading of areas beyond the consolidated lined area
- Completion of the final stormwater management system in coordination with other site work; and
- Preparation and submittal of a final certification report.

The EPD Solid Waste Management Program issued a CCR Permit for AP-1 on February 17, 2022. Therefore, in accordance with 40 CFR 257.102(d), 40 CFR 257.102(f)(2)(i)(D), and 40 CFR 257.102(f)(2)(ii)(B), an extension of two years is requested to complete closure requirements. This additional time requested is required to complete closure activities and obtain the necessary approvals from EPD. This demonstration for extension of closure timeframe will be placed in the facility operating record.
