



EV Charger Rebate

2026 Terms & Conditions for the Georgia Power Company Residential Electric Vehicle Charger Rebate Program

The Rebate Program:

Georgia Power is offering rebate programs to help residential customers cover some of the costs associated with the purchase and installation of electric vehicle (EV) chargers.

Georgia Power customers who install a Level 2 (208/240v) EVSE (charger) may qualify for a rebate for each charger installed (up to 2 per account). This program has limited funds; therefore, rebates are offered for installations completed on or before December 31, 2026, **while funds are available**.

*****Please Note:** You must complete your rebate submission online at the [Georgia Power EV Rebate Portal](#) within **six months after the vehicle charger has been installed**.

Through this process, you will need to provide the following documentation:

1. A copy of the installation invoice must clearly show who installed the charger, the installation address and the date the installation was completed.
2. The charger invoice must clearly show where the charger was purchased.
 - o If charger was provided with purchase of vehicle, it must be individually invoiced or a priced as a line item on the invoice/bill of sale

Georgia Power reserves the right to require additional documentation and to cancel or modify these rebate programs at any time in its sole and absolute discretion with or without advance notice.

Charger Eligibility Requirements and Restrictions:

- Must be a Level 2 (208/240 volt) EVSE (charger).
- Must be a wall or pedestal-mounted charger. Mobile chargers or connectors of any kind, including, but not limited to, the Tesla Charger Gen 2 Mobile Connector are **NOT** eligible for the Georgia Power EV Charger Rebate.
- Must have a dedicated (208/240 volt) circuit. The charger must not share a circuit or outlet with any other piece of equipment.
- Must be new (not used, refurbished, rented, etc.) and purchased by the customer.
 - Chargers gifted or won as part of a raffle or giveaway are not eligible for rebates.
 - Chargers purchased from other utilities' marketplaces/online stores are not eligible for rebates.
 - If your charger is self-installed you may still be eligible for a rebate, you must provide a photo of the installed charger that shows the installed, and a signed and dated document attesting to self-installation.
- Rebate paid on each charger installed if **funding is available**.
- Rebate will not in any event exceed the actual and documented costs the customer incurred in connection with acquiring and installing the charger.
- There is no manufacturer, make or model restrictions, as long as the requirements set forth herein are met.
- Customer must comply with all applicable city, county, or state government, property owner or homeowner's association, rules, codes and regulations during installation of the EV charger. Customer must obtain and maintain all necessary permits prior to and during installation. Level 2 charging occurs at a higher voltage rate than the Level 1 (120 volt) charger, and as a result, an inspection and permit are likely to be required by the city or county where the business or residence is located. Qualified independent electricians can identify what permitting and inspections may be required. Customers are not required to use a participating EV Charger Installer to be eligible for the Residential Electric Vehicle Charger Rebate.

Customer Eligibility Restrictions:

- Must be a Georgia Power customer.
- EV chargers purchased on Georgia Power Marketplace that received the **\$150 instant rebate** are not eligible.
- Eligible customers must be the property owner, or have the express permission of the property owner, to install the EVSE (charger).
- Program is open to all single-family residential customers regardless of electric service rate.
- Residential customers do not have to be on the Plug-In Electric Vehicle (PEV) Rate in order to be eligible for the rebate.
- Residential Customers can receive a maximum of two (2) Residential EVSE (Charger) Rebates per account for the life of the account.

All electric vehicle chargers installed under these programs are subject to visual verification by the Georgia Power Corporate Compliance Organization (GPCCO). If your EVSE (charger) installation is selected for a field audit, you will be contacted by a GPCCO representative to schedule an appointment. By signing and submitting the

Rebate Request Form the customer agrees to provide a GPCCO representative with reasonable access to the installation site during normal business hours. If the field audit discovers that the EV charger has not been installed, the rebate will not be paid, or if the rebate has already been issued, the customer will be responsible for repayment of the rebate to Georgia Power.

Voluntary Data Collection:

Customers participating in the Electric Vehicle Charger Rebate Programs may be contacted to participate in Georgia Power's data collection on EV charging practices in order to better understand EV drivers' charging practices, improve EV services, and encourage greater EV deployment. For example, Georgia Power is interested in collecting information on how many chargers are installed at workplaces and the number and frequency of EV drivers using workplace chargers. Submit your Residential Electric Vehicle Charger Rebate request at georgiapower.com/evrebate along with an installation and a charger invoice. Submission of a request does not guarantee approval. Funding is subject to availability and compliance with applicable terms and conditions.

Other Related EV Rebates:

Builder Incentive for Electric Vehicle Chargers installed in New Homes: Along with other new home rebate incentives, a \$100 rebate is available for builders who install electric vehicle chargers in new homes.
