**AVAILABILITY:**

Throughout Georgia Power's service area from existing lines of adequate capacity. May be limited by the availability of Renewable Energy Credits (RECs) for purchase.

**APPLICABILITY:**

Applicable, upon request, to all retail rate schedules. Georgia Power will match REC purchases to delivered energy on an annual basis.

**DESCRIPTION:**

Simple Solar is a tariff that enables customers to support and foster the growth of solar energy in Georgia by enabling Georgia Power to purchase and retire RECs generated from solar energy resources. The Additional Solar REC Charge will be in addition to the customer's normal cost of electricity and, per the customer's election, will apply to either 50% or 100% of the customer's monthly energy usage.

**MONTHLY RATE:**

**Additional Solar REC Charge..... 1.0000¢ per kWh**

**Note: Per the customer's election, the Additional Solar REC Charge shall apply to 50% or 100% of all kWh's, including RTP kWh's.**

**MUNICIPAL FRANCHISE FEE:**

The bill calculated under this tariff will be increased under the provisions of the Company's effective Municipal Franchise Fee Schedule, including any applicable adjustments.

**TERM OF CONTRACT:**

Service under this tariff shall be for a period of not less than one (1) month. The Company reserves the right to terminate any or all contracts and/or this tariff at the Company's discretion.

State or Federal Legislation Opt-Out Clause: If state or federal laws are instituted requiring Georgia Power to provide renewable resources, the Company reserves the right to cancel all contracts and sales through this tariff, without penalty.

## **LARGE VOLUME PURCHASE OPTION:**

The Large Volume Purchase Option is available to customers who purchase a monthly minimum of 50,000 kWh of RECs and who contract with Georgia Power for a fixed term and a fixed quantity, up to 100% of the customer's annual energy usage. Customers who act as a single brand under (1) common ownership or (2) common control via a written franchise agreement with a single controlling entity may aggregate their annual energy usage load for purposes of participating under this Large Volume Purchase Option.

The Additional Simple Solar Charge for the Large Volume Purchase Option shall be: 1¢ per kWh, per month for the first 50,000 kWh of RECs; 0.8000¢ per kWh, per month for the next 100,000 kWh of RECs; 0.6000¢ per kWh, per month for the next 200,000 kWh of RECs; 0.5000¢ per kWh, per month for the next 1,650,000 kWh of RECs; and all monthly kWh of RECs exceeding 2,000,000 will be at the contracted price.

## **SPECIAL EVENT PURCHASE OPTION:**

Georgia Power may provide a Special Event Purchase Option for special events through one-time REC purchases. A special event refers to a non-permanent assembly (e.g., a conference, concert, sporting event, etc.) and this option cannot be used to procure RECs for permanent facilities. The Company will contract with each interested customer individually to determine the quantity and term.

## **GENERAL TERMS AND CONDITIONS:**

The bill calculated under this tariff is subject to change in such an amount as may be approved and/or amended by the Georgia Public Service Commission.
